Superintendent’s Report – some points highlighted -

- School opened on January 4th after the Holiday break. Did surveillance testing for COVID-19 at the school.
- State looking at vaccination levels.
- Second Stimulus package that was passed had money going to education funds. Not sure what the schools in the district will receive. Funds have restrictions on what they can go towards.

Principal’s Report – some points highlighted –

- Winter sports starting on a limited basis.
- The After School program will be doing snow related activities.
- Suicide Prevention Sessions that have taken place at school.
- Twinfield is ordering Twinfield School t-shirts. They are worn on Fridays.

Discussion on changing School Board Vote date. Need the legislature to pass first.

2021 Town Meeting/School Board Vote – Discussion with Marshfield and Plainfield Select Boards and Town Clerks on moving the Town Meeting and School Board Vote to April 6th. Keeping the meeting joint allows for just single mailings etc. This is contingent on legislature.
